## Reservation Fee \$175 / family

## Administration Fee \$50 / family

This is an administration fee and is not refundable even if you have to cancel out.

## Meals

Camp provides noon and evening meals.

### Breakfast is the responsibility of the camper.

Bring your own breakfast foods and prepare them in the provided facilities.

The first meal served is Sunday noon.

# Camp Oshkidee Family Camp 2010 REGISTRATION POLICY (PLEASE READ CAREFULLY)

- We will begin to process all received applications on March 15, 2010, and you will be notified soon thereafter.  
  
Please fill out all information correctly and get them in early!
- Only pre-registered campers will be allowed to attend camp.
- All registrations must be received by the Registrar at the listed address of the Registrar.**
- All camper registrations received by the deadline will be processed by draw.** An attempt will be made to register families in the week of their choice whenever possible.
- To facilitate the attendance of first or second year campers who may otherwise be reluctant to attend on their own, campers may attach their registration form to that of another family such that the two registrations (attached) shall be processed as one. There shall be a maximum of two registrations per application.**
- The registrar will maintain a waiting list of campers that have applied **on or before the registration deadline**, but could not be accommodated in that year. Those on the waiting list will be given first right of refusal to attend camp for the year immediately following. A refusal to accept will result in the removal of their name from the list. No names shall remain on the waiting list for more than one year.
- Families may apply for multiple weeks. These families will be registered for one week and then placed on the bottom of the waiting list for the other weeks. If a family attends a week of camp, their names will not be carried forward on the waiting list for the following year.

We agree to permit reasonable use of photos and videos or other pictures of the applicant camper in promoting the camp or camp activities and programs.

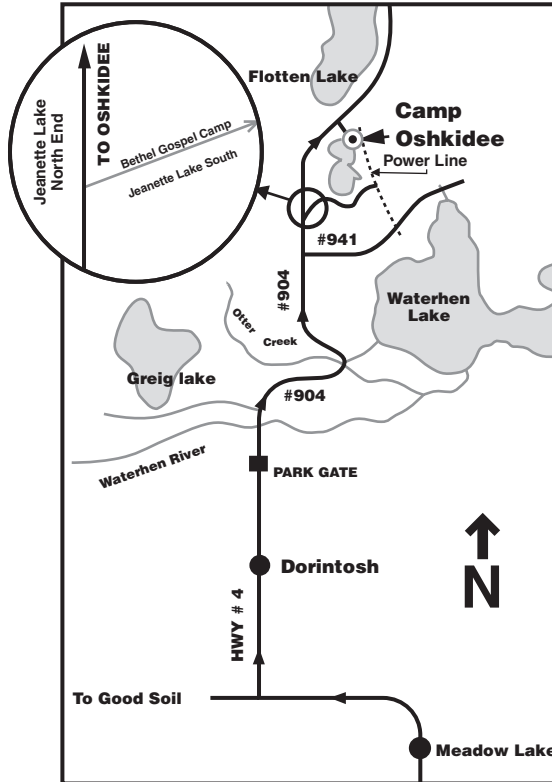
**Hold Harmless**
